PREPARE THE WAY

February 14th is Mardi Gras, or Fat Tuesday when, in ancient times, Catholics finished all the foods that they were forbidden to have in the house during the grim Lents of the early Church. It was a regime austere enough to make us moderns wince.

This is mercifully gone, but the other name for this day whispers a lesson which is still incisively true. The day is Shrove Tuesday, a liturgical memorandum reminding us to be shriven, or absolved. Plainly speaking, we should purify our souls so that we may in our milder Lent, put first things first, and cut down on sin as well as on calories. The diet of the soul (not feeding on anger, pride, or any vice) should go with the fast of the body.

We must understand why the good news of the Gospel has to be seasoned with the salt of Penance. It is not that penance is worth anything for its own sake. No, it is a means to an end. When we say "No" to our appetite, it is not because food and drink are evil. They are gifts of God which we are meant to enjoy. However, we must learn to say "No" to the things which we like, and may have, so that we will have the strength to say "No" to the things we want, and may not have. We will be able to say "No" in time of temptation.

This time of Lent is the opportunity for each Knight to stand apart from his everyday life, and put on the approach of Our Lord to the work of His ministry - - As He prepared Himself with forty days of prayer and fasting, so must we.

At the beginning of Lent, we are asking all the members of the Council to get a good start for this Lenten season by participating in our Day of Recollection on Sunday, Feb. 19th.

TAKE A LONG LOOK

Sit back and take a long look at your position in the Knights of Columbus, take this chance to evaluate your role as far as the Order and Council are concerned.

When you signed your application requesting membership in the Knights perhaps you were fired with the principals and ideals for which our Order is famous, or perhaps you were the "show me" type of guy who will come in for the ride, and if its good, then you will participate.

At any rate the time has passed, your degrees are history and you are now a full fledged Knight. Has the motivation which brought you to the Knights been fulfilled, or have you joined the "boys in the back row" who are still not convinced that this is for them.

In either case, the answer to the long look is the same - - if you are not satisfied, or all is not what it seemed - - the fact of the matter is that you have the corrective medium at your fingertips.

Only your support of six point

action, your active participation at meetings and you're belonging can bring out the ideals you seek and those the Order has to offer. Only you can make the goals and achievements that the Council or Order sets forth. Unity is a part of Knighthood, the principal part of unity is YOU. Are you really a Knight?

The long look should include your attitude, are you willing to work on or for a committee; do you support the activities of the Council; is your criticism always fair and open; do you support your officers and their endeavors; do you think, talk and act Knights of Columbus.

Frankly, if the long look shows you up short, it is time for a change - - back to the ideas and ideals that are the basis of the order, and to those things which had the initial attraction for you.
