A NOTEWORTHY CAUSE

We feel the following letter written to the Parishioners of the St. Michael's Church of Union by Rev. Thomas G. Grant is of such grave importance we are reprinting it in its entirety. Please Heed the Advice Given.

Is State Financial aid to non-public schools a dream or a possibility? In New Jersey, it is a strong possibility because of the Vander Platt Bill (A 553). This bill, if passed, will provide equal aid for public and non-public school children. With your help, it will become a reality just as it is now a reality in New York, Pennsylvania, Ohio, Michigan, Rhode Island and Connecticut.

The Vander Platt Bill will benefit the child directly, and not the school, in that it would observe the child benefit theory confirmed by the Supreme Court, thus, preserving the fundamental right guaranteed by the Constitution and the Bill of Rights for parents to educate their children as they choose.

We appeal to all parishioners to give support to the passage of this piece of legislation in the interests of better education for all our children. You can write a personal letter to your Assemblyman expressing your support of this bill, and urging him to vote for its passage. Among the reasons you can state for your support of the Vander Platt Bill are:

(1) The matter of financial aid has a practical necessity. It is far less expensive to assist non public schools to remain in operation than to allow them to close. The saving to the taxpayers in New Jersey this current year is more than \$200,000,000.

(2) It upholds the natural right of the parents to select the kind of school they wish their children to attend

(3) Such legislation has valid precedence in Federal Legislation which offers the G.I. Bill of Rights, the child benefit theory confirmed by the Supreme Court.

In the interests of better education for all of our children, we earnestly hope and pray that you will heed this appeal now and write a brief letter that is personal in content to your Assemblymen, urging them to vote for the Vander Platt Bill.

Ice Skating Party


We have an Ice Skating Party planned for Saturday, November 15, 1969 at South Mountain Arena. The price wil be a charge of \$.65 for skate rental

We are limited because of space and your comfort to 250 tickets. We have over a thousand members and if all participated we would require space for 2000.


If you intend to go to a council dance order early as possible by calling Herb. Kay, 688-6452.
