# **FUND, CLUB PLANS** TO BE PRESENTED

B. Warren Hehl, Columbian Club president, this week said that a plan to raise funds for construction of a of a building needed for club and council functions, should be ready for presentation to the council before

Hehl's announcement came after the club officers held their regular monthly meeting last Thursday. Meanwhile the club got its first financial boost April 27 when the council adopted a resolution donat-

council adopted a resolution donating \$1,000 to the building fund.

Club officers said they expected that a definate plan to raise funds would be ironed out and presented to the council next month. They also stated a sketch of a proposed clubhouse would be presented by that time.

The club officers have narrowed down their choice of a tract of land on which a clubhouse would be constructed to three parcels in the township. Hehl, however, said the proposed building for a clubhouse will easily be fitted onto any of the parcels.

Club by-laws have been drafted and approved and the Columbian Club incorporation certificate is to be filed with the New Jersey Secretary of State.

TO SEND BOYS TO CAMP A resolution which would appro-priate sufficient funds to send three boys to the K. of C.-sponsored sum-mer camp at Camp Columbus, Culver Lake, will be introduced Monday night.

Cost of the project, sponsored by the Youth Activities Committee, will be \$90.

Grand Knight Howard R. Leary will appoint a nominating committee Monday to select a proposed slate of officers for the 1959-60 year.

Leary has appointed Louis Giacona to head the committee. He said

to head the committee. He said other committee members would be announced at Monday's meeting.

Leary, in announcing his pending appointment of the committee, said he is not seeking re-election as Grand Knight and would decline a nomination for that position.

The committee, to be composed of approximately 12 council members, will select a slate of nine officers, a delegate to the State K. of C. Convention and two alternate delegates. All would be selected for a one-year term effective June 30.

Heading the officer slate will be selection of a candidate for Grand Knight. Other officers to be selected will be, deputy grand knight, chancellor, warden, recorder, advocate, inside guard, outside guard, and one trustee. The trustees are sent to the contraction of the contract Two trustees are currently serving respective terms of two and three years. The lecturer is appointed by the grand knight.

Leary said the nominating committee will be instructed to report back with its slate at the May 25 meeting. He said members who desire to seek an office, or those knowing of prospective officer-candidates should contact him in order dates, should contact him in order that their names might be considered by the committee.

Nominations for all offices will be open to the council at large after the committee presents its slate. Election of officers will be held at the June 8 meeting.

## FINAL DEGREE OF 58-59 YEAR SET FOR JUNE 15

The final degree of the 1958-59 year will be held June 15 when approximately 25 men are expected to receive honors of the First Degree of the Order in a special meeting at the VFW Home.

Most of the prospective members sought membership in the council through letters sent to each family in the parish by the Membership Committee.
