Liturgical Changes Explained

As most of us know, many changes are being made in the liturgy of the Church which are important to all of us as Catholics. In order that all of us be made aware of these changes, we are publishing some of them here for your edification.

AT MASS: Mass will be simpler so you can understand it better, and large parts of it will be in English. You will sing hymns and psalms, and recite a new "prayer of the faithful" after the Gospel. On certain occasions you will receive both bread and wine at Communion.

THE SACRAMENTS: Baptism, marriage and other sacraments will all be in English. Extreme Unction will be for ALL SICK

PEOPLE.

THE SACRAMENTALS: Other musical instruments besides the organ will be heard in church. There will be many revisions in the area of Sacramentals.

LITURGICAL YEAR: Easter may be a fixed permanent date. Many Saints days will be omitted. There will be revised rules for fasting and abstinence.

We may ask ourselves why does the present liturgy need to be "re-

stored?"

Because these are modern times, with modern man's own needs. Many customs and procedures which grew with the Church are no longer needed.

This is why the Vatican Council's aims are two-fold: to fit the liturgy to the times and to restore its original strength and beauty to modern man.


Born and raised in New York City, Vince has been a resident of Union since 1933. According to him there's "no place like Jersey".

TRAGEDY'S COINCIDENCES

One year ago this month, our nation was horrified by the untimely death of our President, John F. Kennedy. Recently a compilation of astounding coincidences between two assassinated Presidents of the United States — Abraham Lincoln and John F. Kennedy — has been seen in many places. The source is unknown, but the facts are extraordinary.

Both President Lincoln and President Kennedy were concerned with the issue of Civil Rights.

Lincoln was elected in 1860 and Kennedy in 1960.

Both Presidents were slain on a Friday and in the presence of their wives.

Their successors, both named Johnson, were Southerners, Democrats, and had previously served in the U.S. Senate.

Andrew Johnson was born in 1808 and Lyndon B. Johnson in 1908.

John Wilkes Booth and Lee Harvey Oswald were both murdered before trials could be arranged.

Booth and Oswald were Southerners favoring unpopular ideas.

Both Presidents' wives lost children through death while residing in the White House.

Lincoln's secretary, whose name was Kennedy, advised him not to go to the theater.

President Kennedy's secretary, whose name was Lincoln, advised him not to go to Dallas.

President Kennedy was shot to death in a Lincoln made by the Ford Co.

Lincoln was shot in Ford's theater.

John Wilkes Booth shot Lincoln in a theater box and afterward ran to a warehouse.

Oswald shot Kennedy from a warehouse and ran to a theater.

The names of Lincoln and Kennedy each contain seven letters.

The names of Andrew Johnson and Lyndon Johnson each contain thirteen letters.

The names John Wilkes Booth and Lee Harvey Oswald each contain fifteen letters.

BALLANTINE DEMONSTRATION

At a bartenders meeting held on October 8th at the Council, Mr. Joseph Lytle, Service Representative of P. Ballantine & Son Breweries gave a talk and demonstration on the proper techniques of tapping and pouring beer.

In his opening remarks Mr. Lytle emphasized that the key to a good glass of beer is three-fold: clean glassware, proper temperature, and accurate pressure. His demonstration included not only the proper techniques, but also some of the more common mistakes made by the non-professional bartender.

Each man present was afforded the opportunity to 'tap' a keg, (a full one) and learn to 'draw' a good glass of beer. The demonstration was an informative one and most of the members present learned many things before the evening ended.

Arrangements for the demonstration were made by Brother Edward J. Pawlowski, who is a Division Manager with the Brewery.

PUBLIC DECENCY

Four judges of the Essex County (New Jersey) Juvenile and Domestic Relations Court in their annual report deplored the easy availability of obscene publications and what they considered the inadequacy of laws dealing with pornography.

The report said: "Delinquents coming before the court have available to them in the public market a vast array of crime stories, masochistic (mas'och-ism: abnormal sexual passion characterized by pleasure in being abused by one's associate), fetishistic (fe-tish-ism: fixation or erotic interest on a part of the body) and obscene magazines containing borderline or lewd stories. The avaivability of such publications in our Essex communities defies description."

The judges expressed the view that "the purveyor is becoming more daring, pushing sales by every means, because he has very little to fear from the law." They called upon parents to exercise proper control of their children's reading material and to provide proper sex education.

They cited the report of α New Jersey leaislative commission which warned in 1962 that "the sale of pornographic material is α \$10,000,000 to \$14,000,000 business in New Jersey and is α serious threat to the ethical and moral well-being of our youth."

Many groups are aware of this threat to our youth and keep the public informed of the problem. One such interested aroup, Operation Yorkville—the interfaith group which is fighting pornography, has called attention to the defense that the American Civil Liberties Union gave to a book dealer accused of selling an alleged pornographic book to a minor. A state law forbidding such practices was declared unconstitutional by the New York Court of Appeals and according to OY has "rendered New York State virtually lawless in the field of obscenity."

A resolution adopted at the eightysecond annual meeting of the Supreme Council of the Knights of Columbus requested that every K. of C. Council establish a committee to seek a commission in each city and town to protect "youth and family life in our communities from the influence of salacious literure." We cannot condone the actions of individuals and groups who in defiance of the common good favor perversion and extreme individualism over the philosophical principles of the Declaration of Independence and the Constitution which call for RIGHT to prevail.

SNOWBALL DANCE

On November 28th the Council will hold its annual Snowball Dance, honoring past Grand Knight William Taylor and past Columbian Club president Wilbur Donnelly. Both these men have contributed much in time, thought and energy to advance our Council to its present position, the best there is.

Think back to the start of the Council year, I'm sure you can see the very evident changes that took place to enhance our Council. The increase in membership, attendance at meetings, social and other functions of the Council and Columbian Club, are the direct result of the leadership and guidance of these two men.

We are presently thinking about hiring the Boy's Club next door, so we can provide you with more room, and at the same time handle an additional two hundred or more people. In this way we hope we can eliminate the disappointment some of you have experienced in the past, due to the limited capacity of our own hall. Additional details are being worked out now, and we will keep you posted of our plans.

As in the past, tickets will be sold on a first come, first served basis. You have the date — November 28th. Make your plans now—we are.
