MESSAGE FROM THE GRAND KNIGHT

My Brother Knights,



As we enter the month of November, two things always come to mind: Election Day and Thanksgiving. This year, both of these days have special significance to us as members of the Knights of Columbus.

In New Jersey, this year's election will enable us to choose our State Assemblymen and Senators, as well as the opportunity to vote on a public question regarding funding for cell stem research to be conducted in the state. At a time when our state faces critical decisions regarding fiscal and ethical responsibility, it is important that we take advantage of our opportunity to vote in this election, and I would urge you all to do so.

Recognizing that voting is an intensely personal decision, please bear in mind when you do so, as Knights, our votes should reflect deep consideration of how a particular candidate's moral views match what we believe, and that their goals are the ones that we desire as practical Catholics.

The public question regarding cell stem research should be of particular interest to us as Catholics. To understand why, it is important to know that this research makes use of both embryonic and adult stem cells. Embryonic cells, whose only purpose is to begin the formation of the human body, are taken from an in-vitro embryo, resulting in its death. To date, these cells have not been found to cure any existing diseases or illnesses. In contrast, 73 cures for human diseases have been found using adult stem cells, which are extracted from amniotic fluid, cord and placenta blood, and in other locations of the body throughout an adult's life. Unfortunately, the public question for New Jersey voters is seeking the authorization of \$450 million tax dollars to fund stem cell research- research that includes the use of use embryonic stem cells. While the Church is not opposed to life saving research, it is clearly opposed to the idea of destroying a life at its very start. If we value human life in all its stages, we should not vote for this question.

Remember as well the full significance of Thanksgiving as you celebrate that event later this month. At a time when the Pilgrims had suffered through some extreme hardships in creating their settlement, they still found the time to thank God for all he had given them. Please take that very powerful thought into your own celebration this year- despite the hardships that all of us endure God is still there to provide for us.

Happy Thanksgiving, and I look forward to seeing many of you on December 1st as we celebrate our very special Council's 50th anniversary.
