Council Activity Program



Whenever we speak of death, we always refer to it as belonging to someone else. We are saddened by the death of a brother knight, and speak well of him. As we pass middle age, we note the obituary columns of the newspapers with ever increasing concern. However, it takes the times of retreat to force us to consider our own death.

It should not be that way for us. We are regularly reminded to pray daily for the grace of a happy death. Now, in the month of November, we are asked to pray for the souls of the departed. We are urged, as well, to think of our own souls.

In the past year, our Lord called home several of our brother knights, of our own council. Should we not ask "Why were they called and not us?" It was certainly within God's power to call any one of us in their stead. If we had been called, would we have been prepared? Not only do I mean preparation through being free from sin; there should be a positive

expectancy that God may call at anytime.

A good attitude to build, with the help of God, is to consider yourself already within the mansion of God. SAFE DRIVING CORNER

Among Catholic car owners, in our country, it has become a wide-spread practice to display, in their cars, statues of Christ, our Blessed Mother of God, and other saints. This move does not meet with opposition from our spiritual leaders. They, perhaps, trust us with the knowledge of our faith, and hope that we may derive many spiritual benefits from this practice. Whatever their thinking, it might well be a good idea to look into and discuss the reasons for displaying these objects.

The foremost purpose would be that it serves us as a reminder of Christian virtues, and of Catholic teachings in particular, which we are to apply and put into practice during our daily life; i.e., driving a car on our crowded highways.

What then are some of these Christian virtues we are to be mindful of?—Christ gave us one great commandment when He said "LOVE THY NEIGHBOR AS THYSELF." To the driver, this simply means practicing charity on the road. It means being courteous to everybody—giving a helping hand. It means giving in an inch once in a while, and, believe it or not, it also includes obeying traffic laws which are made to protect you and your neighbor.

Furthermore, the presence of a statue in a car should inspire its occupants to frequent prayer. This should be a little hint to all of the "backseat drivers"—
It definitely is more beneficial than arguing, and other such practices, which divert the driver's attention from the road.

The display also shows other drivers that you are a Catholic. This is well and fine IF you act like a Catholic gentleman should act on the road. If you are of a contrary opinion in this respect, then you better not display any statues, or someday you, might end up in jail and that is one kind of treatment GOD does not deserve.
