Spiritual and physical health are closely related, a healed spirit can lead to a healed body. That's why Christ can say "Your sins are forgiven" or "Rise and walk."


Christ the Victor:

Crusades for Life Address

At the mid-term Grand Knights meeting Dr. Mildred Jefferson who is the President of the National Right to Life Committee was the main speaker of the day. Her vocabulary, clear diction and magnificent speaking voice captured her audience. Dr. Jefferson spoke for 50 minutes without a note, and never paused or stopped the flow of her talk. She is truly an orator. At the end of her speech there was a thundering standing ovation. This article will cover just the highlights of her talk, and consist of the most important points she made. Dr. Jefferson pointed out what the feeling of most of the citizens in the United States was on abortion before the antiabortion decision of the Supreme Court in 1973, and what influenced its decision. A survey taken in Michigan found 68% said no to abortion. In North Dakota a survey showed 76% opposed abortion. A general poll taken nationwide showed 80% of the majority were finding abortion not acceptable to them. Then what caused the Supreme Court to go against this majority? Dr. Jefferson said it started with Margaret Sanger promoting Birth Control in the 1920's. Then came the efforts of the late John D. Rockefeller and his family, which resulted in influencing the U.S. Government legislation to the tune of 90 million dollars a year supporting the Planned Parenthood activity throughout the country. The Rockefellers got support from other wealthy individuals to break down any laws against abortion. Thus the wealthy and the Planned Parenthood's 90 million dollars had a tremendous influence on the media press, representation, magazine, etc., promoting their views. This was felt by the Supreme Court of 1973. The Supreme Court approved abortion and thus acted in what Dr. Jefferson called "a treasonous" manner to destroy the unborn of our country." We the people can only speak through our legislators! Basic of our rights is the Right to Life. Our way people can control the political process is by defeating those seeking office unwilling to decide on our rights. The Right to Life Movement had its formative years in 1973 to 1975 period. Since then our focus has developed into providing a movement that has made the Right to Life the largest active movement in this country today. We have today gone "From the bottom of the Religious pages into the front pages due to achievements in the 1978 election results. Another area of progress has been made in overcoming the biased media which is shaped by an elusion and delusion of liberalism in the area of abortion. The Right to Life record in the 1978 election showed an even better record than the Union Movement. But election proved new politics are here in the United States. We are bringing politics back to the people." Dr. Jefferson said "Consumer movements, pricereduction groups, fresh air and environmental programs, etc. if they fail in being successful nothing happens to any individual. When we fail lives are lost. Millions of lives are being lost annually and this must be stopped by our efforts and support against the well financed forces and media. This is why we cannot afford to lose. We have to be there electing new congressmen and senators in agreement with the Right to Life views." Through discipline and control the Right to Life Committee has made direct inroads within the circles of Congress. Dr. Mildred Jefferson spoke strongly on the Equal Rights Amendment in connection with the Human Life Amendment. She said "We must help to improve the understanding that E.R.A. and abortion are not to be put together. No judge can tell if E.R.A. passes what effect it will have in the 1973 Supreme Court decision, particularly if E.R.A. is approved first. Consequently, the Human Life Amendment must be passed first. The E.R.A. will remove male and female, mother and father, just the parents' title will remain. It is against the institution of marriage. We still hold to the fact that the family is the basis of our lives. Dr. Jefferson said when it comes to choice on abortion, "there is none when you have a fetus involved. When anyone chooses an abortion, the baby dies and the remains appear in a basin. The woman has a scar on her body and God knows her mental and physical despair and what remains in her heart and on her mind for years to come." At the conclusion of her talk she said, "Our Pro-Life now has a Media Coordinator in every city and town to combat the media bias on a local level by personal contact. We are now at war to those people who will destroy our moral principles. We have to ask that everyone stand up and be counted, never ask people who are Catholic to sit down. The Right to Life Movement encompasses all faiths, colors and ethnic groups working together on this common cause. "We" must bring a caring concern to those who are unable to provide for themselves. Our objective must be — Victory not for ourselves, but for God, America and all mankind." J. M.

A letter from the Newark Archdiocese requesting two representatives to attend the meeting of Council of Catholic Men to be held at the Carteret Hotel in Elizabeth on January 28. A letter was received from Supreme Knight Luke E. Hart thanking us for our stand in requesting that Brother Artucovic of Yugoslavia be allowed to remain in America, and noting that such permission was granted to him and his family.

The following brothers transferred to Union Council: Fred F. Caesar from Council #1831 South Orange, Raymond L. Moy from Council #3731 Glenview, Illinois and John J. Sherry from #3988 Jersey City.

Treasurer Bill Donnelly announced we have \$2,479.92 in the General fund and \$1,269.32 in the death benefit fund. He then donned his other hat and reported as Council Activities Chairman by thanking all who attended the Charter night. He requested that reservations be made early for the annual ball to be held at the Elizabeth Armory on April 4. Reservations must be made for ten or more people, the deadline being March 21. All tickets must be paid in advance to validate a reservation. He stated raffle books are in the mail and introduced Raffle Chairman Vince Squazzo and Souvenir Journal Chairman Pete Rakowski who each made brief pleas on behalf of their respective committees. A request for a group to decorate the Armory on the morning of the dance was also made.

Catholic Activities Chairman Warren Hehl announced Sunday, February 8 as the date for the annual Spiritual Bouquet for the Bishops of the state. He also noted the day of recollection would be held in the upper church at St. Michaels on February 15 from 2 to 5 p.m. with refreshments being served in the school auditorium at the conclusion. People are wonderful in times of tragedy and emergency, and we know that neighbors or relatives will doubtless pitch in and help take care of things during the weeks immediately following her death. But after that, what?

Here are the alternatives open to her husband:

- 1. He could take care of the children by himself. Obviously, this solution would be virtually unworkable. Caring for children and a home while pursuing a career is a heavy task even when both parents share it. Young children cannot be left at home alone. A father-breadwinner cannot stay at home and retain his employment.
- 2. He could get a relative to live with him. In the old days of large, close-knit families, there always seemed to be an able-bodied grandmother or maiden aunt who could take care of the children and keep house if the mother died. But it is impractical to count on such a solution today.
- 3. He could send the children to live with relatives. If this were possible, it would probably mean dividing up the children among relatives. It seems unlikely, though, that any conscientious father would freely consent to this arrangement. Following their mother's death, children need the comfort and security of remaining in their own home, and they need their father's love and attention.
- 4. He could place the children in a foster home. This would probably be the least desirable alternative of all. But it does happen. Some married women with young children do die, and for some widowers this solution unfortunate as it is is the only one possible.

5. He could remarry immediately. It may be that the husband would eventually want to get married again. However, he should not be pushed by economic necessity into remarrying hastily. Both the father and his children need time to adjust to the blow of the mother's death and to start rebuilding their lives.

6. He could hire a governess-house-keeper. Everything considered, this would seem to be the best solution until either the children are grown or the father remarries. In some cities there are agencies that recruit and train competent women to act as "substitute mothers" and homemakers. But it takes a lot of money to hire these people, and they are not always easy to find.

The death of a mother with young children costs her husband a great deal of money. This is not considering loss of income from the family budget if the wife and mother also worked outside the home.

The Cost of a Mother's Death

In the typical situation, a widower with young children is likely to find himself confronted by the following expenses:

- Final expenses Like living costs, dying costs have spiraled in recent years. Medical bills, funeral expenses and probate costs are likely to total at least \$4.000.
- Cost of governess-housekeeper By far the largest single item of expense is the salary of a woman to keep house and take care of the children. A widower would be fortunate to find a good woman to do this for \$4,000 a year, plus board and room.
- Readjustment expenses After his wife dies, a husband needs extra money for at least a year to cover the readjustment expenses of getting the family back to some semblance of a normal living pattern. This would probably take about \$3,200 for the typical family situation.

For purposes of illustration, let us now total the costs arising in the case of a typical widower with young children to care for. Because it's not out of the question that he might remarry within a couple of years, we will limit our estimate to the first two years following his wife's death. During that period alone, total costs might come to something like this:

 Final expenses
 \$4,000

 Housekeeper for 2 years
 8,000

 Readjustment expenses
 3,200

 Total expenses
 \$15,200

Bear in mind that this estimate covers only a two-year period. If the father were not to remarry after that, total costs would eventually be much greater. Furthermore, the above estimates do not take into consideration other miscellaneous expenses and such things as state death taxes, Federal estate taxes and increased Federal income taxes (should any or all apply in an individual situation). In other words, it is likely that \$15,200 would be a **minimum** estimate of the extra expenses a widower with young children would have.

The Ideal Solution

Now we have examined the problem in black and white. We have seen that a wife and mother **does** have a high economic value to her family and that, if she dies, her husband may be hard pressed to come up with enough money to keep his children with him and meet all the other costs and expenses caused by her death. This is a major financial problem — one that is big enough and close enough to home to disturb any husband and wife with young children.

How is the problem best solved? Through life insurance — or, as it is often called, "wife insurance." Only life insurance on her life can guarantee to deliver a substantial number of dollars (the death benefit of the policy) to the proper party (the surviving husband) at precisely the time when those dollars are urgently needed (at the time of the wife's death). Furthermore, life insurance can accomplish all of this for a premium outlay that can be tailored specifically to the family budget.

A sensible procedure to follow in buying wife insurance is first to estimate the total costs incurred in case the wife and mother should die today. Then a reasonable approximation should be made of the amount available for premiums. Finally, with the help of your life underwriter, the kind of policy to buy can be determined by relating the amount of protection needed to the premium the family can afford to pay. **Your Situation**

Perhaps your family should be doing some serious thinking about the **economic value** of a wife and mother. Hopefully, we have raised some questions in this folder which you will want to talk over with each other — and with your life insurance agent. Coming up with reasonable answers **now** could prevent financial headaches and heartaches later.

You may wind up with a long and difficult commute, you probably will have to give up the convenience of nearby neighbors, shops and entertainment, and hard physical labor is often a part of rural living. All of these things are discussed in a 472-page book entitled "Living on a Few Acres." It talks about the satisfactions involved, too. You can order a copy from the Superintendent of Documents, U.S. Government Printing Office, Washington, D. C. 20402.

The government offers another booklet of interest to those who have sons or daughters graduating from college or high school this year. It's a booklet called "Merchandising Your Job Talents" and it can be obtained by sending a check or money order for \$1.20 to Consumer Information Center, Dept. 021F, Pueblo, Colo., 81009. It recommends that graduates-to-be take a hard look at their own abilities and prepare detailed resumes before sending out job application letters or lining up interviews.

Living May Be Hazardous to Your Health Part III

This past June 29th in Seattle, Washington there was a national meeting sponsored by the National Cancer Institute and the American Cancer Society. Some 1,400 physicians attended the conference. According to the participants, increasing research into the nutritional causes of cancer indicates that the American way of eating and cooking may contribute to 40 percent of the nation's cancer deaths. They found fault with the American diet which is high in fat, meat and calories. A preference for broiled, fried and charcoal broiled meats was also cited. Excessive consumption of alcoholic beverages was also mentioned as a major cause of cancer among Americans. A Dr. Ernst Wopnder said "Rather than directly causing cancer, substances in the diet act as modifying or promoting factors that set the stage for the later development of cancer". Note how no one wants to be on record as saying what is the cause of cancer. Only words like contribute, promoting or may result, are used. Dr. John Weisburger of the American Health Foundation said much more research was needed in the role that methods of cooking played in promoting cancer. Dr. Wynder said one or two drinks of alcohol per day was alright but seven or more daily were definitely linked to an increased risk of developing cancer in the upper respiratory and digestive tracts. So recent research tells us to greatly decrease the chances of getting cancer, we not only have to move out of the mid-Atlantic states area, but watch smoking and drinking, and stop "cooking and eating the American way" Judging by the evidence on hand we can worry each day about getting cancer, or we can live in reasonable moderation not worrying excessively about these factors, but enjoy life as it comes day by day.
