

# Grand Knight's Message

We are fast approaching the Holy Christmas Season and it is for us only to reflect upon the many assets which we are to be thankful for in recognizing that we celebrate truly Christ's birthday.

Notwithstanding, many of our blessings there are those in this country and others who seek to downgrade the effect of this Holyday of December 25, 1965, to a more commercial and mercantile effect in an attempt to take away from our Lord and Master due respect and reverence on His birthday.

As Knights of Columbus it is our duty to exemplify in all of our actions, words and deeds, the continued pronouncement that this day belongs to Christ and for his honor, do everything we can to continue this respect, love and admiration for our standard bearer.

Let us, therefore, invoke our will to display bumper stickers, pro-nouncement by words and deeds when we are able to do so to our friends, not only of our faith, but otherwise that this day belongs to our Lord and Master and not other commercial businessmen who so ably and cleverly seek to put profit above respect.

We cannot complain for the lack of respect of this day ourselves when we, too, are guilty of providing the respect and dignity that is due our Lord. Henceforth, be so admonished to upgrade our personal feelings in this respect.

We should further make every effort to instill in our families and children, the remembrance of what this day means to them over and above their joy in receiving gifts, for were it not for the birth of Christ, there would be no Christmas Day.

#### PUBLIC DECENCY

Dr. John W. McDevitt, Supreme Knight of the Knights of Columbus presented an address titled "A Moral Counteroffensive" to the Fourth National Convention of the Citizens For Decent Literature at New York.

Following are a few excerpts from Supreme Knight McDevitt's powerful address: ". . . The said and oft repeated lesson of history teaches us that in vain does a bronze shield defend the heart of a country if the innermost core of the nation's heart is eaten away by the dry rot of im-

Most Americans will simply ignore your efforts for decency. Some will deride you. Because you want decency, they will call you Victorians; because you resent smut, they will call you prudes; because you resist immorality, they will call you old-fashioned; and because you want to help our youth, they will call you 'do-gooders.' And cruelest of all, some misguided ultra-liberals who think that any curb on pornography is a threat to our constitutional rights of free speech, will even call you unpatriotic.

But despite this rather sad picture of general apathy and even hostility I am optimistic about achieving the basic aims of the movement for decency in literature.

My optimism is based on the tremendous reservoir of good will and good sense that the American public has ever shown when given the full facts on a problem  $\dots$ 

I believe that the great initiative that individuals and organizations can take in this area is to alert the American public to the menace . .

These points should be brought home emphatically to the public.

- 1. Pornographic material is readily available to our young people, in astonishing quantities and at relatively low cost.
- 2. Pornography is having a decisively deleterious effect on the  $% \left\{ 1\right\} =\left\{ 1\right\} =\left\{$ young as indicated in the rising rate of sex crimes.
- 3. Even if a parent feels that his or her children are being protected from this debauching filth, they may become the victim of another youth who has become depraved by it.
- 4. There already exist some safeguards against this virus, which generally need only proper implementation . . .

I also can report that the Knights of Columbus succeeded in having the National Fraternal Congress, representing 98 societies and nearly ten million members, take note of the menace of pornography and pass a unanimous resolution pledging a campaign against it at the association's September meeting in Washington."

#### PARISH COMMITTEE

In the Newark Archdiocesan Campaign for decency in literature and in motion pictures, it is Archbishop Boland's specific and urgent request that a permanent committee for this purpose be erected in each parish throughout the four counties of the Archdiocese. This committee must have a Spiritual Director, Lay Chairman and a membership depending on the number of merchants and movie houses in the parish area. The membership must be chosen with great care since they are asked to shoulder a great burden which is perennial and thankless. Both men and women make up this membership. Women are especially needed since visitations are called for during the daytime.

Join your parish committee and help in this request of Archbishop Boland. Encourage others to join.
